**BYLAW NO. 03-2019**

**A BYLAW OF THE TOWN OF WATROUS TO FIX THE RATES TO BE CHARGED FOR THE USE AND CONSUMPTION OF WATER AND TO FIX THE RATES TO BE CHARGED BY WAY OF RENT OR SERVICE CHARGE FOR THE USE OF SEWER**

The COUNCIL of the Town of Watrous, in the Province of Saskatchewan, enacts as follows:

1. The charges to be paid by the water consumer whose water service has been turned on shall be those set out in Schedule "A" attached; provided, however, that the minimum shall be payable in every case whether or not any water is consumed.
2. Persons who own or occupy premises drained or that are by bylaw required to be drained into the sewer shall pay for such services a rental rate or service charge in accordance with Schedule "B" attached.
3. Water consumers shall pay a Capital Infrastructure Fee in accordance with Schedule "C" attached.
4. Accounts for water service and/or sewer service shall cover a period of two successive months and shall be rendered on or about the first day of the month next following such period. Accounts shall be paid within a period of thirty days from the date on which such accounts are rendered. If an account is not paid within the period of thirty days, the water service may be cut off. When the water service is cut off, it shall not be turned on until all arrears have been paid, together with a fee of \$40.00 to cover the expenses of turning off the water and turning it on again; provided that if it is required to turn on the water service outside the employees' regular working hours, the fee shall be \$100.00.
5. The Town of Watrous has the right to ration or limit the amount of water supplied to any or all consumers should circumstances warrant such action.
6. A penalty of 2% shall be added to all water and sewer accounts outstanding 30 days after such accounts are rendered.
7. Bylaw No. 05-2018 is hereby repealed.

THE rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on approval being issued by the Local Government Committee.
